Presented for selfless dedication to humanity and contributions to Collaboratory



Collaboratory presented Patricia K. Dobbins the prestigious John W. Sheppard Award. Named after a founder of the Southwest Florida Community Foundation, the John W. Sheppard Award is given to outstanding trustees who have given selfless dedication to humanity and made significant contributions to the Foundation. Past recipients include John W. Sheppard, David Lucas, Peter Kleist, Arnold Sarlo, Frank Bireley, Jim Nathan, Sam Galloway, Jr., Tom Smoot, David G. Robinson, Bill Frey, Gene Solomon, Dawn-Marie Driscoll and Jay Brett.

Dobbins is a senior advisor for Collaboratory and has been involved with the foundation since 2009. She has practiced professional nursing for 45 years in a variety of settings. Her experience includes working for the Veteran's Administration; both urban and rural hospital settings; as a nurse educator for 15 years in a public school district and as an entrepreneur owning her own consulting/case management business.

She previously served as the Administrator of the Health Departments in both Hendry and Glades counties. She was appointed to the leadership position after 18 years as the Executive Community Health Nursing Director. Dobbins received her undergraduate degree in Nursing from Northern Illinois University and a master's degree from NOVA University. Following retirement, Dobbins has provided consultative services to small businesses, rural organizations and regional nonprofits. She mentors young people who want to have a career in health, especially first-generation college students.

She serves on numerous local, regional and state boards, committees, task forces and coalitions as an advocate and voice for rural uninsured or underinsured and rural health disparities. She has served in leadership roles for the Florida Association of Public Health Nurses (FAPHN), the Florida Public Health Association (FPHA), and received a Public Health Nursing Leadership Award. She is an alumnus of the University of South Florida Public Health Leadership Institute, the Robert Wood Johnson Executive Nurse Fellows program and the National Rural Health Association Fellows program.

Dobbins has served as an Adjunct Professor at Florida Gulf Coast University and is on the School of Nursing's Advisory Board. She is also a member of the Florida Rural Health Association and serves as a trustee for the Healthy Start Board, Hendry/Glades Mental Health Board and the AHEC Board.

Grantmaking

Community foundations distribute grants to nonprofits and other organizations through different processes and types of funds. Competitive grants are typically awarded based on factors such as alignment with the foundation's mission, demonstrated need, and potential for impact. We have aligned our Grantmaking to our community leadership and capacity building strategy.



Scholarships

In 2024, thanks to our scholarship fundholders, we awarded more than \$1.2 million and 279 scholarships to local high school students, undergraduate, graduate students and adult learners from Charlotte, Collier, Glades, Hendry and Lee counties. Over 150 volunteer application reviewers were vital to the process. Some examples of the scholarships available were based on community service, academics, fields of study, athletics, or even students that are attending or attended a particular school.

Hurricane Ian Response

Two Years Later

In response to Hurricane Ian, one of the most devastating natural disasters in history to hit the State of Florida, Collaboratory launched a relief fund to help our area rebuild and support local nonprofits helping individuals with immediate and long-term resources to fuel recovery.

Collaboratory established the SWFL Emergency Relief Fund in partnership with United Way of Lee, Hendry, and Glades Counties. The fund supported Southwest Florida nonprofits across the five-county region, helping individuals and small businesses with the most pressing needs. In addition to the SWFL Emergency Relief Fund, Collaboratory created its long-term Rebuild Southwest Florida Fund. Close to \$900,000 has been raised and is in the process of being granted to organizations focused on creating community resilience through ongoing recovery and rebuilding initiatives. So far, the funds have been granted as follows:





Hurricane Milton Response

In preparation for Hurricane Milton, Collaboratory opened the Hurricane Milton Relief Fund to collectively help Southwest Florida rebuild, supporting local nonprofits helping individuals needing immediate and long-term resources to recover.

Southwest Florida was expected to experience 125+ mph winds, intense rainfall and a significant storm surge causing catastrophic destruction, massive power outages, and widespread flooding.


Collaboratory launched the SWFL Emergency Relief Fund in partnership with United Way of Lee, Hendry, and Glades Counties. As an organization serving the five county region, the fund supports Southwest Florida nonprofits helping people and areas of most pressing need. Donors can contribute at collaboratory.org.

Fund Development & Management

Community foundations generally maintain a variety of fund types from donor advised funds to agency endowment funds to designated and field-of-interest funds. Community foundations and other charitable organizations may also have relationships with supporting organizations.



Fostering Success

For over 26 years, Fostering Success has been dedicated to serving children who are or were in foster care by providing opportunities that empower each child to reach their full potential. What began as a small effort to fulfill requests for basic necessities has grown into a leading organization that addresses the educational and social needs of foster children. Today, we proudly support 750 children annually in Southwest Florida.

Our programs are organized into two key pillars: education and enrichment.



Education

- Ready for Kindergarten: Connects foster children aged 0-5 with quality early learning centers to prepare them for school.
- Academic Mentoring: Offers free tutoring to students aged 5-18 with open or closed dependency court cases, ensuring consistent academic support.
- Scholarships: Provides financial assistance to high school seniors who are or were in the foster care system, enabling them to pursue higher education.

Enrichment

- Project Enrichment: Supplies essential items such as diapers, cribs, beds, clothing, school supplies, and uniforms. It also enables foster children to participate in activities like summer camps, afterschool programs, sports, music, arts, theater, and dance—fostering skill development, friendship, and fun.
- Thriving After Care: Supports young adults aged 18-23 transitioning out of the foster care system by teaching vital life skills such as cooking, financial literacy, resume building, job applications, securing housing, and pursuing advanced education.

At Fostering Success, we understand that addressing the needs of the whole child is critical. Emotional healing and social growth are essential prerequisites for achievement.

Our impact is evident. Last year, 100 percent of the children in our programs graduated from high school, significantly exceeding the national graduation rate of 50 percent.




Community Leadership

Community foundations often act as conveners, bringing together diverse stakeholders to address community issues. They may organize forums, workshops, or other events that foster collaboration and collective problem solving. As we collectively drive toward 2040, our Community Leadership role is to resource, engage, and coordinate regional coalitions aligned around shared goals to change regional outcomes given that no single entity can solve a big social problem on its own.

Power of Partnerships

At the Power of Partnerships event, leaders and changemakers came together to share ideas on how to build a stronger, more connected region. The event underscored the passionate commitment of individuals and organizations working toward a flourishing community and highlighted Collaboratory's role in supporting and amplifying their efforts.

As a community foundation, Collaboratory remains dedicated to addressing immediate needs while also taking a long-term, proactive approach to problem-solving. The conversation emphasized the importance of upstream solutions—tackling challenges at their source rather than just responding to symptoms. By convening diverse community stakeholders and facilitating collective action, Collaboratory is driving real, systemic change.





This commitment is evident in the expansion of regional coalitions, with a focus on housing, health and wellness, and the early development of two additional initiatives centered on Southwest Florida's built and natural environments. The discussion reinforced a core belief: sustainable solutions require collaboration, shared vision, and the power of partnerships to generate resources, align efforts, and create lasting impact.

As Collaboratory continues its work toward solving Southwest Florida's most pressing challenges by 2040, the event served as a powerful reminder that transformation happens when a community comes together to take bold action.



co•a•li•tion: an alliance for combined action

Recognizing that big social problems cannot be solved by a single organization, Collaboratory launched 3 cross-sector coalitions to improve regional outcomes and achieve the goals of our donors by making a positive impact in our communities. FutureMakers Coalition (established in 2015), which focuses on the education and workforce system, is the prototype for two new coalitions to make sure everyone in Southwest Florida can afford housing and enjoy good health.









A Higher Degree of Human & Economic Development

In 2024, FutureMarkers Coalition grew exponentially; in partnerships, diversified programming and funding streams, and outcomes. Over 180 organizations and 260 individuals are now recognized FutureMakers partners, and participation among regional employers increased 30% since 2023. A total of 13 new project teams were created to address workforce development goals and strategies, while five grants were awarded and two new corporate sponsors invested in FutureMakers Coalition.

To date, \$2.2 million dollars have been distributed through the Equitable Jobs Pipeline to support wrap around services that enable adults who need to reconnect with education and training to get into good jobs here in Southwest Florida. In the same time frame, \$5.78 million was committed to training partners and employers.





Building a Healthier Southwest Florida

The Health and Wellness Coalition achieved significant milestones in advancing our shared goal of being among one of the healthiest communities in the nation by exceeding the 90th percentile for health indicators (length of life and quality of life) by 2040.

The coalition engaged over 300 partners, integrating two major health initiatives, Healthy Lee, and Blue Zones Project, to strengthen its impact. A guiding team was established, supported by four new coordinators hired in January, to provide backbone support and foster collaboration. Four regional action teams now drive outcomes in active living, behavioral health, food access and nutrition, and health systems. Additionally, a baseline partnership health report showed that 92% of respondents identify as partners and believe our collective efforts will significantly improve regional health outcomes.





Making Affordable Housing Accessible for All

This year, the Home Coalition made remarkable strides in advancing the shared goal that 80% of people in Southwest Florida will have access to housing and transportation that costs less than 45% of their income by 2040. Engaging over 160 individuals from 120+ organizations, the Home Coalition established a Guiding Team, three Regional Action Teams, and nine project teams, fostering collaboration committed to transformative change.

The inaugural Home Coalition Partnership Health Report revealed that 89% of respondents believe our collective efforts can significantly improve regional housing outcomes. With support from Bank of America and Lake Michigan Credit Union, we commissioned a Regional Housing Study to identify strategies for financing and developing more attainable housing; its recommendations, expected in January 2025, will guide future action.





Capacity Building

Community foundations often provide training and resources to strengthen the capacity of local nonprofit organizations. They may offer workshops on topics such as fundraising, board development, and strategic planning, as well as provide access to research, data, and best practices to help nonprofits improve their effectiveness and sustainability. In addition to the coalition onboarding program we provide, we are offering training and resources to regional partner organizations to strengthen our collective ability to solve problems together.

Workshops

Grant Writing Workshop

JANUARY 2024

Collaboratory welcomed community partners for an engaging grant writing workshop focused on strengthening nonprofit program development, proposal writing, and capacity building. Led by Dr. Madeleine Kahn, the session provided valuable insights and strategies to enhance funding opportunities and drive greater impact.



Data Best Practices Workshop MARCH 2024

We partnered with Florida Gulf Coast University's RERI and SFLI to host a free workshop focused on using data effectively to drive impact. Participants gained valuable insights into data collection, maintenance, analysis, and reporting, learning best practices for integrating datadriven approaches into decision-making and accountability.



The Power of Clarity: Logic Models for Nonprofits

This workshop, led by Rachel Walter, was designed to help nonprofit organizations strengthen their impact by effectively communicating and measuring the change they create. Attendees explored strategies to build stronger programs, enhance accountability, and achieve meaningful outcomes.
